MRPG OLD BUSINESS

- 2ft Draw down application was submitted by the Town last week, still no State response.
 - No update from Jim Ventres as of 7/8/25.
- Grass Carp
 - Contacted Irene Haines to see if she can assist. Response to her email to the State was that Moodus Reservoir is a large body of water and DEP must be involved and survey.
 - Dave attempted to contact, but recipient on vacation.
- Newsletter Next newsletter should be after information has been received regarding the 2ft drawdown and also after the boat parade. Suggested that 2 newsletters be published one at beginning of season and one at end of season.
- Boating Safety Course Class dates of 7/22/25 and 7/24/25 set up with instructor. Posted at billboards on both reservoirs. People are being put on waiting list as 40 student limit has been reached. Noted that people are registering for classes from towns outside of the immediate area. May be possible for locals who have been placed on wait list to join class, if others do not attend.
- Wake Boats –After attending meeting with Town on 6/25/25, it was suggested that Moodus Reservoir be separated from Bashan Lake regarding any ordinance about wake boats as the lakes are very different, namely in depth. Letter has been written and will be submitted to Irene Haines. Motion to submit letter was made and accepted. On 7/16/25 there will be a Selectman Meeting to discuss the wake boat issue and whether it should be brought to vote.
